How long do we keep your data?

Your rights and your personal data

Unless subject to an exemption under GDPR, you have the following rights with respect to your personal data:-

- The right to request a copy of your personal data DB Automotive BRTN LTD holds about you
- The right to request that DB Automotive BRTN LTD correct any personal data if it is found to be inaccurate or out of date
- The right to request your personal data is erased where it is no longer necessary for DB Automotive BRTN LTD to retain such data
- The right to withdraw your consent to the further processing of your data
- The right to request that data controller provide the data subject with all personal data and where possible to transmit the data directly to another data controller
- The right where there is a dispute in relation to the accuracy or processing of your personal data , to request a restriction is placed on any further processing.
- The right to lodge a complaint with the Information Commissioner's Office
